

In-Parish Tuition Subsidy Requirements

Those who meet the following criterion, receive subsidized parish tuition. A parishioner is someone who:

- Participates regularly (weekly) in the most important aspect of parish life, namely Sunday and Holy Day liturgies.
- Is involved in the life and activity of the parish, giving at least five hours per year of time and talent.
- Has officially stepped forward and named Assumption, Sacred Heart or a parish in the NW Corner Catholic Community as her/his parish community by registering at that parish.
- Realizes the need to be a financially contributing and active member of the parish by completing a Stewardship of Treasure pledge card and working toward fulfilling that commitment.

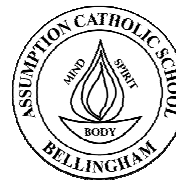
